- ◆ “By Girls, For Girls” (GAB) was the first girls grantmaking program in Pennsylvania and is one of only 11 in the United States.
- ◆ Over 100 Chester County high school girls have served on the Girls Advisory Board since 2004.
- ◆ GAB has awarded 51 grants, totaling \$150,000, to address the needs of girls in our community, such as hunger, prevention for substance abuse and safe after-school programs.

BRIDGE OF HOPE LANCASTER AND CHESTER COUNTIES

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$10,000 Program Support

The Fund grant will be used through the Social Work Services for Homeless Women program to focus on providing case management, budget training, parenting training and other social services for women residing in Chester County.

CHESTER COUNTY COMMUNITY DENTAL CENTER

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$12,000 Program Support

Approximately 5,000 low-income, uninsured or underinsured women and girls in Chester County will receive dental care and dental health education, through the Women and Girls Comprehensive Dental Care program, with the help of their Fund grant.

CHESTER COUNTY FOOD BANK

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$12,000 Program Support
\$4,750 GAB Grant

The Fund and GAB grants will help prevent childhood hunger through the Girls' Backpack Program which ensures low-income girls have nutritious food during the weekend.



CHESTER COUNTY FUTURES

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$7,000 Program Support

The GirlsEd101 program addresses the positive and healthy development of vulnerable Chester County girls in grades 6-12 while improving their school and personal performance.

COMMUNITY VOLUNTEERS IN MEDICINE

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$12,000 Program Support
\$3,000 GAB Grant

Approximately 800 uninsured Latina women and girls will receive free medical and dental care with the help of a Fund grant, through CVIM's Healthcare.

CRIME VICTIMS' CENTER OF CHESTER COUNTY, INC.

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$17,000 Program Support

The Fund grant will support five programs for women and girls who have been sexually assaulted and/or abused, including a self-esteem group for teens, a support group for women in Phoenixville and a new Latina support group in Kennett Square.

DOMESTIC VIOLENCE CENTER OF CHESTER COUNTY

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$18,000 General Operating

The Domestic Violence Center of Chester County offers intervention, programs, outreach and advocacy to prevent, reduce and remedy domestic violence in Chester County, including services that are designed to reduce victims' financial barriers and strengthen their ability to become safe and self-sufficient members of the community.

DOWNINGTOWN AREA SENIOR CENTER

AREAS SERVED: Northern, Eastern & Western
Chester County

AMOUNT: \$10,000 Program Support

With the grant from the Fund, the Downingtown Area Senior Center will help senior women by providing information and assistance with such issues as transportation, affordable housing and medical benefits.

THE GARAGE COMMUNITY AND YOUTH CENTER

AREAS SERVED: Southern Chester County

AMOUNT: \$2,500 GAB Grant

The GAB grant will support several after-school programs that focus on girls' positive development, including GirlTalk for high school girls, Sister Sister for middle school girls, and tutoring and mentoring programs.

INTERFAITH HOUSING ASSISTANCE CORPORATION OF CHESTER COUNTY

AREAS SERVED: Northern, Southern, Eastern & Western
Chester County

AMOUNT: \$5,000 General Operating

Interfaith Housing Assistance Corporation of Chester County provides case management and financial assistance to help single parent families with dependent children (under age 18) avoid homelessness and achieve self-sufficiency in Chester County.

KENNETT AREA SENIOR CENTER IN COLLABORATION WITH OXFORD AREA SENIOR CENTER

AREAS SERVED: Southern Chester County

AMOUNT: \$11,500 Program Support

Kennett Area Senior Center and Oxford Area Senior Center's collaborative Wellness and Independence program serves senior women in Southern Chester County with year-round activities, screenings and workshops, fostering socialization, wellness, mobility and safety.

LA COMUNIDAD HISPANA

AREAS SERVED: Southern and Western Chester County

AMOUNT: \$13,000 Program Support

The Prenatal Health Program provides culturally competent, comprehensive health care services tailored to meet the needs of pregnant Latina women in Southern Chester County regardless of their income or health insurance.

The Fund was the first endowment-based women's fund in Pennsylvania. We have raised over \$5 million from thousands of individuals, corporations and foundations in support of the needs of women and girls.



MATERNAL AND CHILD HEALTH CONSORTIUM (MCHC)

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$15,000 General Operating

The Fund operating grant will assist with overall administrative and program costs for MCHC's Healthy Start program which serves more than 1,000 pregnant and parenting women each year.

ORION COMMUNITIES, INC.

AREAS SERVED: Northern Chester County

AMOUNT: \$5,500 Program Support

Orion reaches out to the most vulnerable in the community, serving a population which has exhausted most other resources available for ending the cycle of poverty. The Fund grant will be used to support the Families from Crisis Program which provides long-term, intensive individualized assistance for "at risk" single parent families, all female led.

PARKESBURG POINT*

AREAS SERVED: Western Chester County

AMOUNT: \$6,000 Program Support

The Parkesburg Point Girl's Program provides girls with a safe, after-school environment, as well as opportunities to build positive self-esteem and supportive networks through innovative programs.

PENNSYLVANIA HOME OF THE SPARROW

AREAS SERVED: Northern, Southern, Eastern & Western Chester County

AMOUNT: \$17,000 General Operating
\$4,250 GAB Grant

The Pennsylvania Home of the Sparrow provides housing and supportive services to homeless and low-income women (ages 18-64) and their children, who want to improve their lives and become self-sufficient. The GAB grant will support the Transitional Housing Program, which provides housing and comprehensive services for women with children, including job training, parenting classes, budget training, domestic violence support, and GED preparation.

SAFE HARBOR OF CHESTER COUNTY, INC.

AREA SERVED: Northern, Southern, Eastern & Western
Chester County

AMOUNT: \$12,000 Program Support

The Fund grant will support the Women's Recovery Program which focuses on moving women shelter residents closer to an independent existence by developing action plans that address individual needs and providing life skills training.

THE CLINIC

AREAS SERVED: Northern, Eastern & Western
Chester County

AMOUNT: \$10,000 Program Support
\$2,000 GAB Grant

The Fund and GAB grants will be used for the Women's Reproductive Health Program, offering women the opportunity to receive necessary tests to ensure reproductive health and safety.

VOLUNTEER ENGLISH PROGRAM

AREAS SERVED: Northern, Eastern & Western
Chester County

AMOUNT: \$12,000 General Operating

Volunteer English Program serves adult immigrants and refugees, the majority of whom are women, providing free tutoring to improve English language skills necessary for employment, self-sufficiency and economic stability.

YOUNGMOMS*

AREAS SERVED: Southern Chester County

AMOUNT: \$3,500 GAB Grant

The GAB grant will support one-on-one weekly mentoring, enrichment activities and support groups for teen mothers between the ages of 15 and 20.

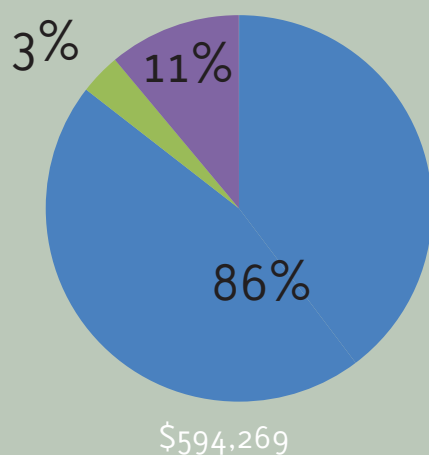

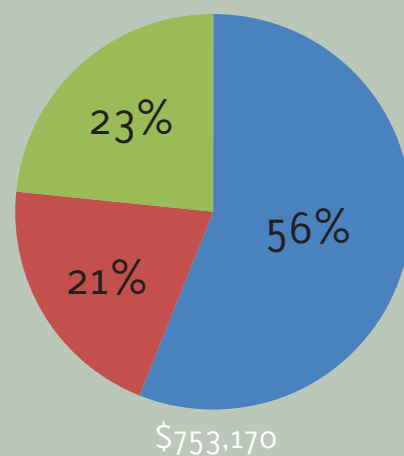
